
PETITION FOR THE ANNEXATION OF TERRITORY

To the Board of the Town of Concord, County of Erie, State of New York:

To the Board of the Village of Springville, County of Erie, State of New York:

PURSUANT to General Municipal Law Article 17, the Petitioner, ROLOC CORP., petitions for the annexation of territory from the Town of Concord, New York (hereinafter the "Town"), to the Village of Springville, New York, to wit:

1. The Petitioner proposes and petitions that your Honorable Town Board permit and allow to be annexed to the Village the territory as more particularly described in **Exhibit "A"**, attached hereto and made a part hereof.
2. The Petitioner proposes and petitions that your Honorable Village Board permit and allow to be annexed to the Village, the territory as more particularly described in **Exhibit "A"**, attached hereto and made a part hereof.
3. The Petitioner herein is the owner of the majority, in fact, all of the assessed valuation of the real property in said territory, as described in **Exhibit "A"**, assessed upon the last preceding Town Assessment Roll of the Town.
4. There are no inhabitants of said territory, which territory the Petitioner petitions to have annexed to said Village.
5. Attached hereto and made apart hereof is **Exhibit "B"**, a survey map of the proposed territory to be annexed.

6. Attached hereto and marked **Exhibit "C"**, is a copy of the most recent tax bill for the existing parcel from which this parcel shall be divided and broken off, certifying that the petitioners are the owners of a majority in assessed valuation of the real property in the territory herein proposed to be annexed to the Village and now situated in the Town as shown on the last preceding assessment role of the Town.

7. Petitioner, upon information and belief, believes that the annexation requested is to the benefit of both the Town of Concord and the Village of Springville, as well as in the best interest of the public at large.

IN WITNESS WHEREOF, Petitioner hereby requests that their Petition be granted and that the subject parcel be annexed into the Village of Springville.

BEGINNING at a point in the center line of South Cascade Drive, also known as Park Road and also known as NYS Route 219, distant 545.55 feet South from the intersection of said center line with the north line of lot number eleven (11). 
